Portwest® Glowtex Executive Jacket Style G475, constructed from a 124g/m² warp knitted polyester fabric in yellow or orange. The garment features one horizontal band of sewn on retro-reflective tape encircling the torso with over the shoulder bands, and two bands of retro-reflective tape encircling each arm. Additionally, a 5 cm band of photo luminescent material is sewn on at the chest and back, and a 4.5 cm band of photo luminescent material is sewn on immediately above the horizontal retro-reflective band. The garment has a mobile phone pocket on the right breast and two lower bellow pockets with flaps. The garment is available in eight nominal sizes the smallest being S.

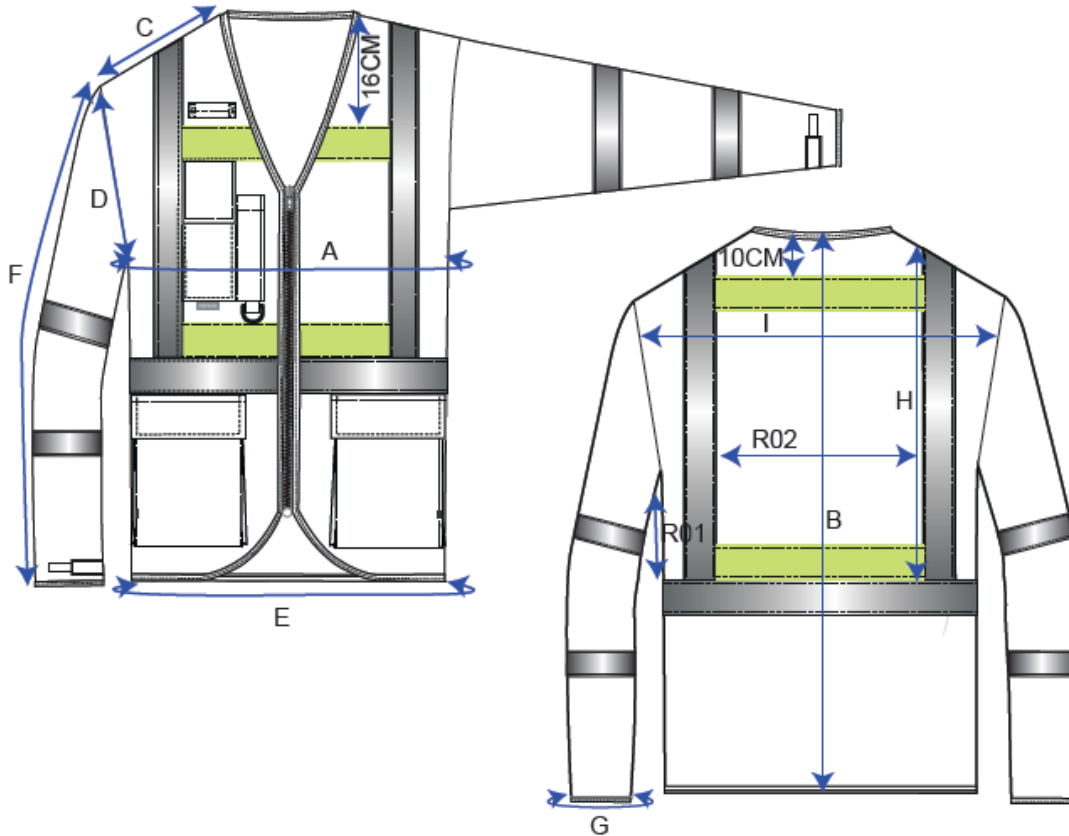
